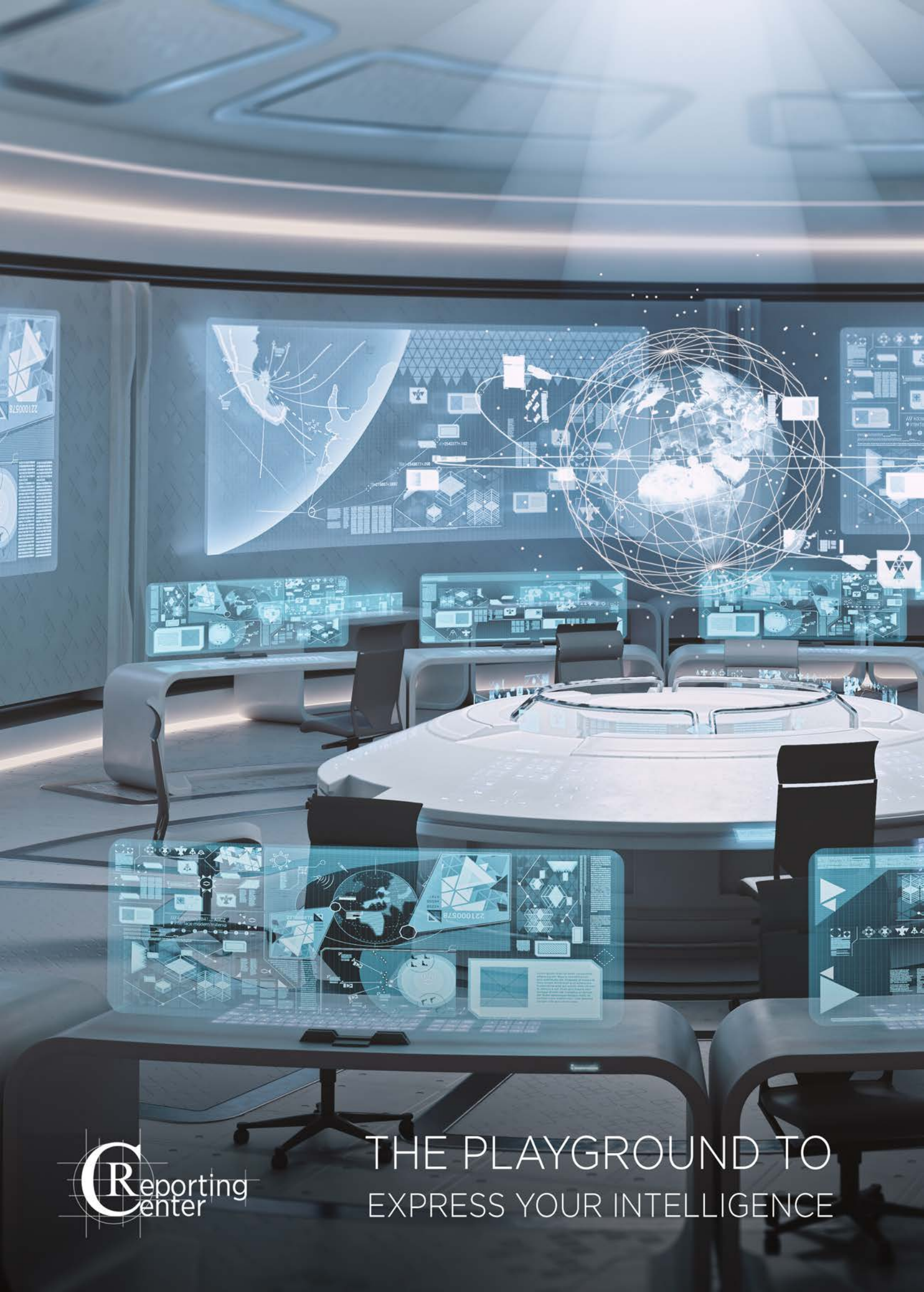

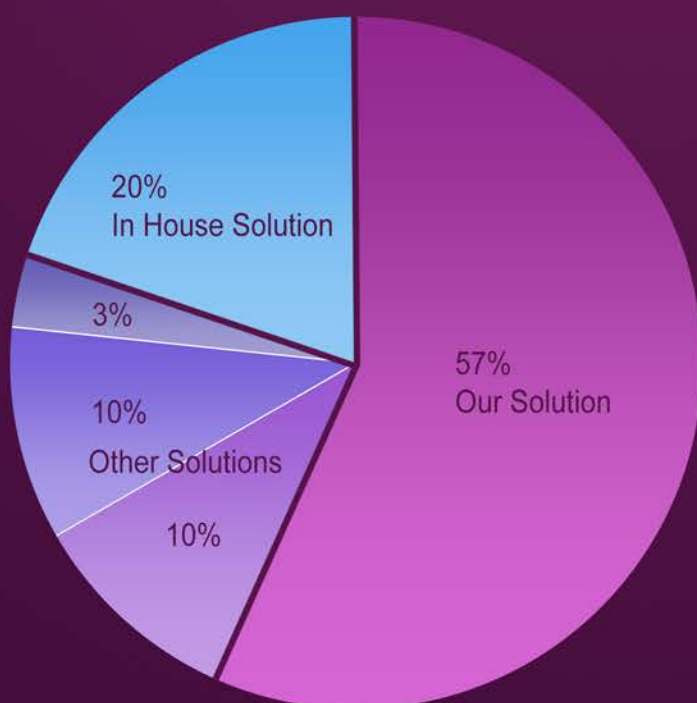

# PURPLE EXPERTISE

When it comes to Business Intelligence projects, the paradox is: more people involved, more struggle to achieve results. The traditional approach is: business analysts exchange documents with technical analysts and then with developers and then with project managers and finally with business owners. By the time the product is done the specs are modified and the process reiterated.

This is the problem with **large customers**: from idea to realization the process is too long. Their need: FAST implementation.

On the other hand, **small customers** have limited resources – small teams and low budget. Their need: AFFORDABLE estimation.

They would be pleasantly surprised by the team's youth and the high level of training.

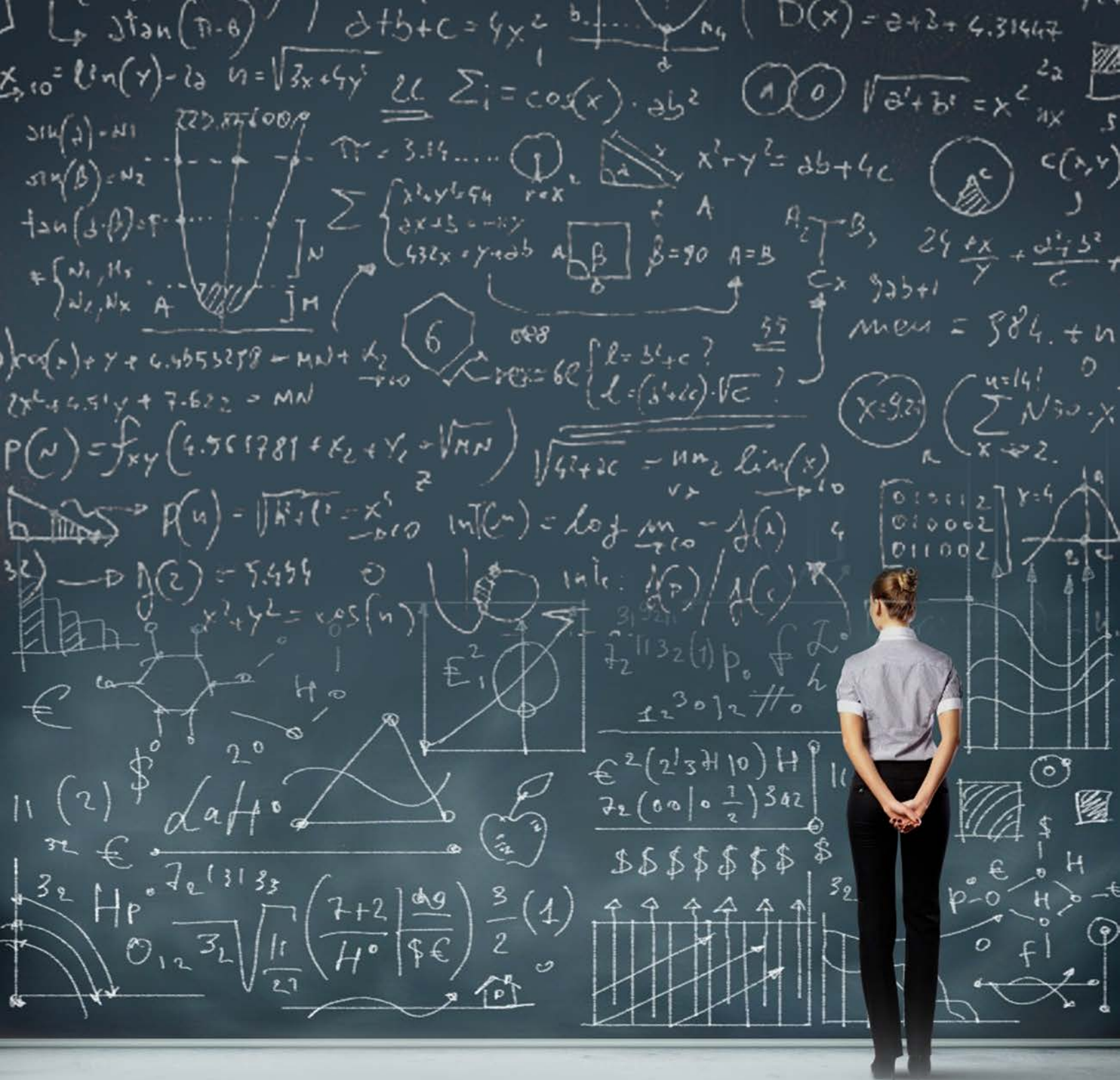
## **What was the biggest struggle your team had to overcome?**

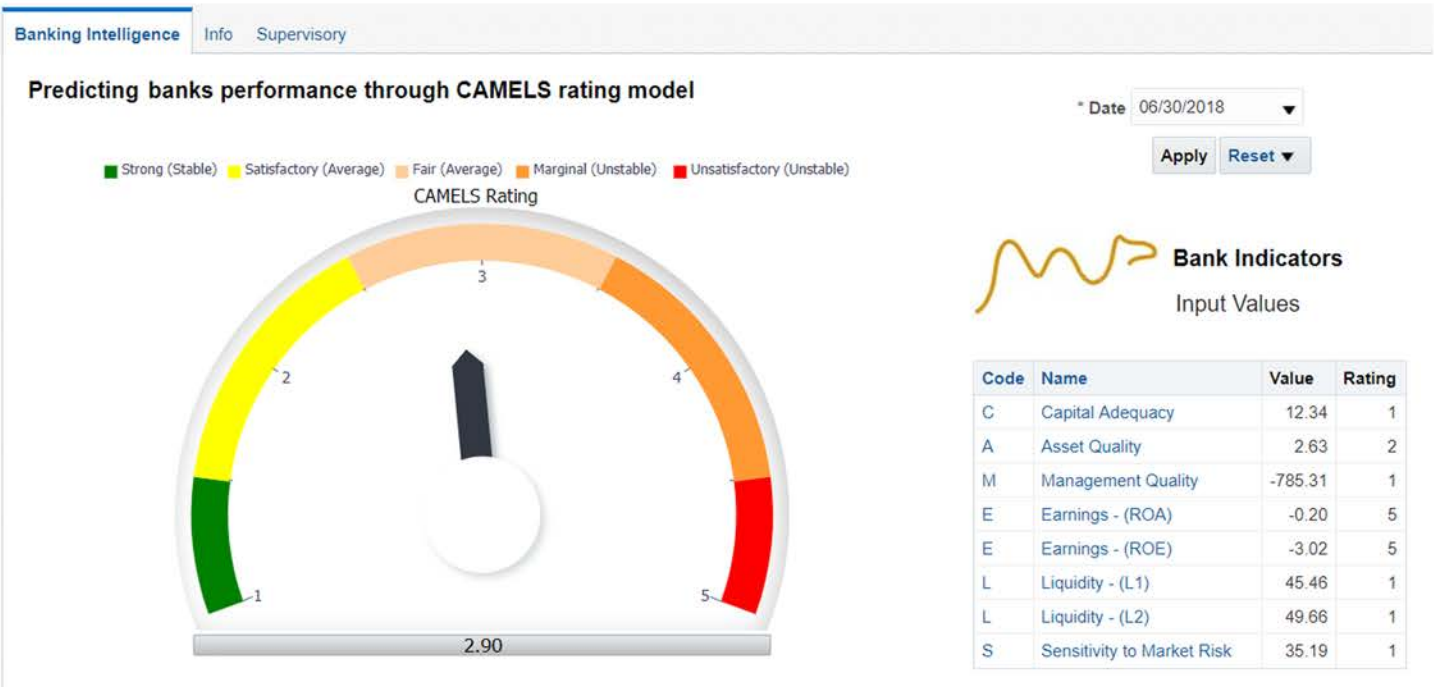
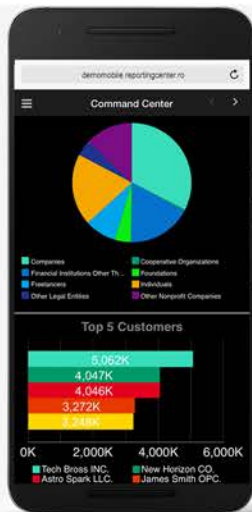

# BUSINESS INTELLIGENCE

Gartner said that 70% to 80% of the Business Intelligence initiatives end up failing. Our approach? Make sure our Customers are aware of the Gartner 4 best practices in BI.

## Choose a Business Problem That Offers an Initial Win

BI and analytics leaders need to work with business leaders to identify problems to tackle. Review with them the outcomes that drive the business and identify the decisions that could provide the biggest impact or, in many cases, the quickest payback. These may include day-to-day operational decisions, tactical decisions (such as planning), or infrequent strategic decisions (such as whether and when to enter new geographies). Wherever there is a lot of data, uncertainty and complexity, there is opportunity.

## Use Outsourcing and Buy Packaged Apps When You Lack Advanced Analytics Expertise

Many organizations assume they must continue on their current path with a centralized BI team and tools, and therefore build advanced analytics capabilities themselves. However, there are other options that are better suited to quick wins. Organizations that don't themselves have the skills to build advanced analytics can use external service providers who do, or buy advanced analytics applications to show the value of advanced analytics expertise for a particular problem.

## Identify the Stakeholders in Your Organization That Need to Be Convinced of the Value of Advanced Analytics

It's essential to identify the internal stakeholders who need to be convinced. These are the naysayers, the skeptics, and perhaps the decision makers or those who carry out the actions. Not having them on board can derail any project. Having a business case that demonstrates the value is, of course, necessary, but it may not be enough on its own. The hardest task is to change people's beliefs and how they see the world — to get them to understand why they need to think or act differently. "Frequently, the success of advanced analytics initiatives comes down to the ability not only to deliver the analytics or communicate their value, but also to create a data-driven culture," said Ms. Kart.

## Decide If You Want to Build the Skills and Tools Internally

Businesses that achieve best-in-class advanced analytics solutions typically do so through a build strategy. However, building the skills and tools internally isn't for everyone, and it's often not the best way to start.

BI and analytics leaders that do decide to build must have the three core skills needed for advanced analytics:

*Business skills:* Apply analytics to the right problems and ask the right questions.

*IT skills:* Access the data, identify the required infrastructure and execute the insights.

*Data science and quantitative skills:* Take the right analytic approach to the data.

Unfortunately, this skill set is rarely found in one person, but it's essential to have all three skills within a team.

It covers data extraction, data parse, file upload custom sources, compute algorithms, export reports in standard format (Excel, XBRL, XML, CSV, TXT, etc.). It contains a kernel for reports computation and a repository with all the Statutory Reports required by the European Banking Authorities. Additionally, it offers drill-down to the lowest level of detail, data versioning, manual adjustments, reconciliation and audit logs.

Our products are innovative through precision. When it comes to reporting to the State Authorities you need extremely high accuracy, 100% to be exactly. Our advantage is that we don't give up until we reach the required quality standards. In our field of work, being a hard worker is more important than talent, because the legislation keeps changing and you have to continually adapt.

## DATA WAREHOUSE

The platform is modular, that means we can install a module and then add other modules on request. We can build your entire Data Warehouse from scratch or configure only the Reporting Data Mart. The loading frequency is flexible: daily, monthly etc. You can choose from the following modules: Statutory / Group / MIS Reporting, Trial Balance, IFRS / Group Provisions, Basel III, Forbearance, Multidimensional Profitability, Command Center, the consolidation in case of bank merger, prior or post-merger.

## TECHNOLOGY

The application is built on Oracle technology: Oracle Database, Oracle WebLogic 12c, Oracle ADF, Oracle Business Intelligence. Most of our Customers have chosen the On-Premises version, but we do advise them to try also the Cloud version.
